

**AGA Montgomery

FY 2014 - 2015**

Goal:

Offer 30+ continuing professional education hours (CPEs) to chapter members and guests.

1. Offer 12 CPEs for Fall Education Seminar on November 13-14, 2014:
 - a. Provide a quality program by increasing accounting and auditing (A&A) hours for practitioners and members maintaining certification.
 - b. Publicize the seminar through media streams, social media, brochures, emails, website, etc.
 - c. Integrate practical break-out sessions in the program
 - d. November 13 will be an optional half day training focusing on Young Professionals (YP). The goal is to provide option for members who want more CPEs and emphasize on YP developments.
 - e. Open registration by September 1, 2014.
 - f. Details to be determined.

2. Offer 6 to 8 CPEs during monthly Luncheons:
 - a. Two-hour CPEs in one afternoon setting for monthly luncheons in February (Young Professional) and March (CGFM).
 - b. One to Two hour CPEs for joint meeting with IIA and Military Comptroller in December and January.
 - c. Details to be determined.

3. Offer 8 CPEs for Spring Education Seminar on April 17, 2015:
 - a. Provide a quality program by increasing A&A hours for practitioners and members maintaining certification
 - b. Publicize the seminar through media streams, social media, brochures, emails, website, etc.
 - c. Foster relationship with Faulkner University's School of Business and enhance the awareness of AGA Faulkner's campus
 - d. Open registration by February 1, 2015

4. Offer 8 CPEs through live classroom settings:
 - a. Partner with Professors from local Universities to provide additional CPEs.

7. Promote education opportunities provided by partnering local organizations:

 - b. Annual local IIA training conference
 - c. Annual local GFOAA training conference
 - d. Annual local AMCA training conference

 - f. Monthly local ACFE training events
